Terms & Limitations of the Plan

- The Wellness Plan is **NOT** Dental Insurance and is only valid at the office of Dr. Molly Slack, D.D.S.. It is available to all uninsured patients and cannot be combined with any dental insurance plan.
- Benefit coverage is effective for participants who **remain enrolled** in their plan at least until the completion of treatment. Treatments and services not utilized at the end of each year's membership period are not carried over to the following year. Patients are responsible for scheduling their periodic treatments and services.
- It may not be **combined** with any other offers.
- This plan is **non-transferrable** between family members.
- Only family members that reside in the **same household** are eligible to join for a discounted family rate. Families with children up to 23 years old may participate. The adult child must be enrolled as a full-time student. Otherwise, the maximum age for the discounted family rate is 18 years old.
- Participants are automatically enrolled into the **free look period**, wherein participants can cancel their enrollment within the first 30 days, with a full refund.
- After the conclusion of the **free look period**, participants can cancel their enrollment without a refund
- Payments are due at time of service. No cash or credit card discounts will be applied to payments. If payments are made via CareCredit, there will be a 5% surcharge. Rates are subject to change annually. The effective date begins at sign up when monthly or annual premium is paid. The renewal date is the same date every year.
- For those enrolled in monthly plans, credit card information will be securely stored for electronic payment.
- The Wellness Plan applies towards dental treatment and services only, not products such as whitening and toothpaste.
- The Wellness Plan cannot be used for dental treatment associated with any type of injury where a lawsuit, disability, or workman's comp are involved.
- All your membership information will be kept in your secure electronic record. No ID card, group or member number will be needed.
- This plan may be modified, amended, or canceled at any time with 30 days notice. Please see our office policy regarding missed, canceled, or broken appointments without proper notice.
